FREQUENTLY ASKED SUBSCRIPTION QUESTIONS

Q. What is the phone number to call in case of emergency?

A. 9-1-1

Q. Will my subscription benefit cover someone living with me?

A. Yes. If you subscribe as a household, your subscription benefit covers all family members living at the listed address who require emergency medical care, regardless of whether they are treated and/or transported to a hospital.

Q. When does my subscription benefit expire?

A. Your subscription benefit will expire on February 28, 2026.

Q. When is my subscription benefit due?

A. You can subscribe at any time, but please keep in mind that your 2024 subscription benefit expires on February 28, 2025. To continue coverage, please send your subscription benefit payment before that time. Also, we do not prorate subscriptions if you pay midway through the year.

Q. Can I pay with a credit card?

A. Yes. Please complete the back of the enclosed form and return it to our office.

Q. Does a subscription benefit cover both emergency and non-emergency trips?

A. No, only emergency trips are covered by a subscription benefit.

Q. If I have a subscription benefit, is the ambulance free?

A. We will still bill your insurance company and accept their rate assignment. Your insurance company may have a deductible that you are responsible for, but you will not be responsible for the co-payments or any other charges due for emergency transport.

Q. If I do not subscribe, how much of the bill will I be responsible for?

A. You will be responsible for the entire balance remaining after your insurance pays.

Q. I have a high deductible. Will this subscription benefit cover it?

A. No. You are responsible for your deductible, but this subscription benefit will cover your copayments and co-insurance on an emergency trip.

Q. If I do not have insurance or my insurance does not cover my emergency trip and I do not subscribe, how much could my bill be?

A. Depending on the care needed, the bill could be between \$850-\$1,200 per trip.

Q. If I do not subscribe, will the ambulance deny emergency transportation to me?

A. No. An ambulance will always come when you dial 9-1-1.

Q. Can I choose which hospital I want to go to?

A. We are required to transport you to the nearest facility. If you choose to go to a different hospital and your insurance denies the claim, you will be responsible for the outstanding balance.

Subscription Benefit Rates:

- Single: \$50.00 Anyone 18 years of age or older
- **Couple: \$60.00** Two (2) individuals 18 years of age or older
- Household: \$75.00 Includes all related individuals living as a family unit in one household, regardless of age. This includes family members of several generations – i.e. grandparents, parents, their children living in the household. Only names listed on the back of the enclosed card will be covered.
- Visitors: \$15.00 The visitor plan can be added to any of the above plans. This will cover any visitor who is transported from your home. Same subscription benefit rules apply.
- Business: \$150.00 Employees and non-residential customers at your place of business during working hours.
